Staff Summary: The Council agreed to send one member of the Highly Migratory Species Advisory Subpanel (HMSAS) to participate in the March 5-7 North Pacific albacore management strategy evaluation workshop to be held by the International Scientific Committee for Tuna and Tuna-like Species (ISC) in Yokohama, Japan. The HMSAS member will report back to the Council on workshop outcomes.

The Council tasked the Highly Migratory Species Management Team (HMSMT) to work with the HMSAS in summarizing historical North Pacific albacore catch and effort to provide support for Inter-American Tropical Tuna Commission (IATTC) discussions on defining effort. The HMSMT is anticipated to report back on findings at the March 2019 meeting.

In response to <u>IATTC Resolution C-18-01</u>, which establishes a 600 mt 2019-20 commercial catch limit for west coast fisheries catch of Pacific bluefin tuna, NMFS is developing regulations for trip limits to ensure the catch limits are not exceeded and the annual sublimit is no more than 425 mt. The Council made recommendations on these regulations at the September 2018 meeting. In November, NMFS reported on the measures it was planning to implement, which incorporate most of the Council's September recommendations (see <u>Supplemental NMFS Report 2</u>). Staff Summary: The Council adopted a final range of alternatives for authorizing use of deep-set buoy gear (DSBG) as described in <u>HMSMT Report 1</u>, including modifications and the range of qualification rankings found in <u>Supplemental HMSMT Report 2</u>, except that Alternative 3, Stand-Alone drift gillnet (DGN) Permit Trade-in, is removed from the range. The Council also incorporated both the alternative proposed in <u>Supplemental HMSAS Report 1</u>, and the public comment provided by Ms. Tara Brock in <u>Supplemental Public Comment 2</u> as part of the final range of alternatives.

The Council adopted a preliminary preferred alternative (PPA) for a limited entry permit program for vessels fishing in Federal waters east of 120° 28' 18" W. Longitude. As described under Alternative 2 in <u>HMSMT Report 1</u>, all other Federal waters offshore of California and Oregon would be "open access."

The Council's PPA is a variation of Alternative 1 described in <u>Supplemental HMSMT Report 2</u>. Alternative 1 provides an ordered list of qualifying criteria to be used to determine the order of applicants to whom a limited entry DSBG permit would be issued. Individuals could only possess one limited entry permit. Fifty permits would be issued initially with up to 25 permits issued annually in subsequent years until either a maximum of 300 permits are issued or NMFS or the Council determines that less than 300 permits should be issued. The Council PPA prioritizes active DSBG EFP and DGN fishery participants. Details of the ranking criteria for permit issuance may be found in the <u>Council motion</u> for this agenda item.

b. In drafting the process and timeline, consider the workload associated with:

- i. developing proposed changes to the FMP structure and language to clarify the description of the management strategies for CPS fisheries, and
- ii. retain the flexibility to consider revising the management strategies for a particular stock through a routine process (e.g., through a regular specifications and management process, rather than an FMP amendment).

Each atsea whiting sector will manage their bycatch of canary rockfish and widow rockfish using sector-specific total eatch limits. For the at-sea sectors, groundfish species other than whiting are managed as set asides, amounts for which are based on the best available information on bycatch by these sectors and other relevant factors, including, but not limited to, status of the set-aside stocks, expected utilization in other sectors of the fishery, and expected management conditions in any sector in upcoming fishing years, as determined in the biennial harvest specifications and management measures decision process. The sector allocations of these select groundfish species under Amendment 21 and Amendment 21-3 is as follows: The set aside amounts come from the trawl allocation, with the remainder (after deducting the set-asides) going to the shoreside sector allocation.

Council Operating Procedure 2 – Advisory Subpanels

A subpanel member <u>should attend all meetings</u>, <u>but</u> may <u>request an alternate with</u> <u>appropriate expertise for the position if unable to attend a meeting</u>. <u>Members may</u> request an alternate for a subpanel meeting no more than twice per calendar year under the following terms. <u>All requests for alternates require prior approval of the Executive Director</u>. The Executive Director must be notified in advance in writing with the name of and contact information for the proposed alternate at least two weeks <u>30 days</u> prior to the first day of the advisory body meeting, or the first day of the Council meeting held in conjunction with the advisory body meeting. The alternate will be reimbursed for travel expenses per the Council travel rules. Exceptions to these terms may be made at the discretion of the Executive Director for highly unusual occurrences.

Council Operating Procedure 3 – Plan, Technical, and Management Teams

A Team member <u>should attend all meetings</u>, <u>but</u> may <u>request an alternate with appropriate</u> <u>expertise for the position if unable to attend a meeting</u>. <u>Members may</u> request an alternate for a Team meeting when the official member is unable to attend under the following terms. <u>All requests for alternates require prior approval by the Executive Director</u>. The alternate is expected to fulfill the primary duties of the absent member and the Executive Director must be notified in advance in writing with the name of and contact information for the proposed alternate at two weeks <u>30 days</u> prior to the first day of the advisory body meeting, or the first day of the Council meeting held in conjunction with the Team meeting. Nonfederal alternates will be reimbursed for travel expenses per the Council travel rules. Exceptions to these terms may be made at the discretion of the Executive Director for highly unusual occurrences.

Council Operating Procedure 4 – Scientific and Statistical Committee

<u>Members should attend all meetings, but members may, with prior approval by the Executive Director, request an alternate.</u> When an appointed member representing a Federal, state, or tribal agency (categories 1, 2, and 3) will not be able to attend a meeting, a designee may be

appointed if the Executive Director is notified in advance in writing with the name of and contact information for the proposed alternate at least two weeks <u>30 days</u> prior to the first day of the advisory body meeting, or the first day of the Council meeting held in conjunction with the advisory body meeting. Exceptions to these terms may be made at the discretion of the Executive Director for highly unusual occurrences. Such designees may participate in committee deliberations as a regular member and non-federal alternates shall be reimbursed for expenses per the Council travel rules. Designees for at-large committee members are not authorized.

Council Operating Procedure 5 – Enforcement Consultants

An Enforcement Consultant <u>should attend all meetings</u>, <u>but</u> may <u>request an alternate with</u> appropriate expertise for the position if unable to attend a meeting. An Enforcement <u>Consultant may</u> request an alternate for a meeting no more than twice per calendar year under the following terms. <u>All requests for alternates require prior approval by the Executive Director</u>. The Executive Director must be notified in advance in writing with the name of and contact information for the proposed alternate at least <u>two weeks 30 days</u> prior to the first day of the Council meeting held in conjunction with the enforcement meeting. Non-federal alternates will be reimbursed for travel expenses per the Council travel rules as long as the official member is not in attendance. Exceptions to these terms may be made at the discretion of the Executive Director for highly unusual occurrences.

Council Operating Procedure 6 – Habitat Committee

A Committee members <u>should attend all meetings, but</u> may <u>request an alternate with</u> appropriate expertise for the position if unable to attend a meeting. Members may request an alternate for a meeting no more than twice per calendar year under the following terms. <u>All</u> requests for alternates require prior approval by the Executive Director. The Executive Director must be notified in advance in writing with the name of and contact information for the proposed alternate at least two weeks <u>30 days</u> prior to the first day of the HC meeting, or the first day of the Council meeting held in conjunction with the HC meeting. Non-federal alternates will be reimbursed for travel expenses per the Council travel rules. Exceptions to these terms may be made at the discretion of the Executive Director for highly unusual occurrences.

Council Operating Procedure 7 – Groundfish Allocation Committee

A Committee members <u>should attend all meetings</u>, <u>but</u> may <u>request an alternate with</u> <u>appropriate expertise for the position if unable to attend a meeting</u>. <u>Members may</u> request an alternate for a meeting no more than twice per calendar year under the following terms. <u>All</u> <u>requests for alternates require prior approval by the Executive Director</u>. The Executive Director must be notified in advance in writing with the name of and contact information for the proposed alternate at least two weeks <u>30 days</u> prior to the first day of the Groundfish Allocation meeting, or the first day of the Council meeting held in conjunction with the Groundfish Allocation meeting. Non-federal alternates will be reimbursed for travel expenses per the Council travel rules. Exceptions to these terms may be made at the discretion of the Executive Director for highly unusual occurrences.

Council Operating Procedure 8 – Ad Hoc Committees

Due to the limited and specific nature of Ad Hoc Committees, members shall, generally, not be allowed to appoint alternates and are strongly encouraged to attend all Ad Hoc Committee meetings. However, a member may request an alternate to a meeting no more than twice per calendar year under the following terms. <u>All requests for alternates require prior approval by</u> <u>the Executive Director</u>. The Executive Director must be notified in advance in writing with the name of and contact information for the proposed alternate at least <u>two weeks 30 days</u> prior to the first day of the committee meeting, or the first day of the Council meeting held in conjunction with the committee meeting. Non-federal alternates will be reimbursed for travel expenses per the Council travel rules. Exceptions to these terms may be made at the discretion of the Executive Director for highly unusual occurrences. Such designees may participate in Ad Hoc Committee deliberations as a regular member.
